Joe Grogan, Caledon Resident, provided a presentation regarding Air Quality in Caledon. Mr. Grogan presented information on the potential impacts of commercial diesel engines and aggregate production on the air quality in the Town. He requested that the Town conduct air quality testing in several areas of Caledon that are subject to large volumes of commercial diesel truck traffic and aggregate production. Mr. Grogan citied several articles that discuss the potential side effects of air pollution created by diesel engines and aggregate production. Mr. Grogan concluded the presentation requesting Council to address air quality concerns within the Town.
