#### INTRODUCTION

Acting Town Clerk, L. Hall, advised that due to the COVID-19 pandemic and Bill 187, Emergency Management Act, 2020, that the meeting would be held as an electronic meeting and open to the public through an audio broadcast and remote public participation. She advised Members of Committee of procedural functions of the meeting.

#### **CALL TO ORDER**

Chair N. deBoer called the meeting to order in the Council Chamber at 7:05 p.m.

#### **DISCLOSURE OF PECUNIARY INTEREST**

None.

#### **PUBLIC MEETING**

Chair N. deBoer advised that the purpose of the public meeting is to obtain input from the public. He noted that any interested persons with concerns, appeals or requesting further notification regarding any of the proposed applications should contact staff in the Legislative Services division.

### 1. Proposed Official Plan Amendment and Rezoning Application for 16054 and 16060 Airport Road, Ward 3

Chair N. deBoer confirmed with Margherita Cosentino, Community Planner, that notification was conducted in accordance with the *Planning Act*.

Michael Vani, Senior Planner, Weston Consulting, provided a presentation regarding the proposed official plan amendment and zoning by-law amendment application for 16054 and 16060 Airport Road. He advised that the proposed applications are to permit a Tim Horton's restaurant with a drive-thru on two existing lots. He noted that the focal point of this application is to promote commercial development and business in Caledon East. Mr. Vani highlighted that he will continue to work with urban design staff to ensure the design of the development compliments the existing community. Mr. Vani explained that he is working with the Region on access and the required road widening. He further advised that the Town has requested an air quality assessment which will be submitted. Mr. Vani recognized the level of public interest and indicated that Weston Consulting would be hosting an open house on the application in the coming months to further discuss the application.

#### **PUBLIC COMMENTS**

David Frost advised that he was a member of the Caledon East Secondary Plan Committee. During that time, the Committee chose to ban drive-thru establishments in Caledon East, which was later approved as part of the Caledon East Secondary Plan. He raised concerns that the proposed development will attract more vehicular traffic and idling of vehicles. In addition, he expressed concerns of excess noise with the proximity of the proposed location to his home and concluded by expressing his opposition to the location of the development.

Chris Tranquada sought clarification if the increase in traffic from Airport Road and Walkers Road is being considered and questioned the requirement for turn lanes on Airport Road.

Raquel Tranquada advised that her questions and comments were addressed through Mr. Frost and Mr. Tranquada's comments

Fernando Velocci expressed concerns with the increase in traffic the proposed development will create. He noted traffic concerns already exist at the intersection of Old Church Road and Airport Road and the number of driveways accessing Airport Road in the village core. He highlighted that in his opinion, the proposed development will not be for the residents of Caledon East, but for the traffic driving through Caledon East. He identified that Caledon East has existing restaurants to service the area. He concluded by expressing his opposition of the proposed development application.

Sagi Denenberg indicated that some of his comments have been addressed by other speakers. He highlighted that the local bakeries provide all of the refreshments that Tim Hortons would offer, and residents should be supporting local businesses. He has concerns with the amount of garbage and littering that Tim Hortons will bring to Caledon East and the traffic impacts. He indicated that people move to Caledon East for the small-town community feel and suggested that Tim Horton's relocate to the Foodland plaza at the south end.

Jim Watson expressed support with the concerns already mentioned by the previous speakers relating to the noise of a drive-thru window, idling of vehicles and the increase of excess traffic. He indicated that he is not opposed to Airport Road redevelopment but is not in support of a Tim Horton's at the proposed subject property. He inquired about how deliveries would be managed. Mr. Watson explained that in his opinion the noise wall will not eliminate the noise, but rather mitigate it.

Natalie De Sousa advised that she agrees with the other comments made and explained that she has made a written submission. She advised that Airport Road is a truck route. She sought clarification if during the traffic study it was taken into consideration the vehicles parked on the side of Airport Road. In addition, she recommends that the Tim Hortons include a restaurant only and remove the drive-thru component. Finally Ms. De Sousa is concerned with what will happen to the existing heritage dwellings and inquired if the owner would consider developing the site for a use other than a Tim Horton's.

Filomena Coulas advised that she prepared a petition on change.org in support of the proposed development for a Tim Hortons in Caledon East. She indicated that she understands why the residents residing in close proximity of the property would not be in support. Ms. Coulas asked staff how many times this development has been proposed and whether or not there have been any spin-offs for the community. She inquired if the applicant would consider moving the location south end of the village.

Tyler Schiller advised that his comments and questions have already been addressed.

Sandra Scarvone identified her agreement with the concerns raised by Mr. Watson and Mr. Velocci and expressed concerns with the increase in the loitering this proposed development would bring to Caledon East. She suggested that other locations surrounding Caledon East may be more appropriate, specifically identifying King Street and Airport Road. She identified concerns with trucks parking along Airport Road, and that the drivethru will not attract residents but rather commuters. In addition, she expressed concerns with the idling of vehicles and the impact on the environment.

Jacquie lafrate expressed her support for the proposed application, while also recognizing the opinion of others. She expressed concerns with the limited number of jobs available for youth, especially with no transit. She indicated that she has concerns on environmental impacts (garbage, idling, etc.).

Mark Prieur is opposed to the proposed location being on Airport Road. He expressed concerns with heavy trucks parking on Airport Road, especially with the increasing amount of traffic in the village. He explained that although the proposed development will offer jobs, it may detract or reduce other jobs if other local businesses cannot compete.

Sherry Brioschi, a resident of Bolton, provided insight to the Tim Hortons in Bolton highlighting the traffic congestion concerns that are present due to the restaurant. She noted that Airport Road is a high-traffic route, expressed concerns with trucks parking on the side of the road and access for Emergency Responders. Ms. Brioschi advised that the Tim Hortons coffee cups are not bio-degradable and has concerns with the potential littering in the area. She highlighted concerns with water and salt use. She expressed that she cannot support the proposed application and does not want to see drive-thru in Caledon East. Ms. Brioschi asked if Tim Horton's put a survey out to discuss the needs of the community and wants to see evidence that the development is supported by the community. Ms. Brioschi is concerned with the impact on small businesses and asked if there would be a second public meeting. She requested a third-party review.

Anthony Ciccodemarco advised that driver behaviour will lead to further pressure on Municipal Law Enforcement and Police Officer presence. He indicated that there is parking information missing from the Traffic Impact Study. Mr. Ciccodemarco requested that a traffic accident analysis study be completed as he does not feel the proposed location supports a Tim Horton's restaurant.

Members of Committee asked questions in relation to several of the comments made by members of the public and received a response from the consultants and staff.

The following are my comments regarding the Proposed Official Plan Amendment and Zoning By-law Amendment to accommodate the construction of a Tim Horton's Restaurant with drive-through.

I have lived in Caledon East since 1978. At that time, Caledon East was a small, safe, friendly village where neighbours and residents looked out for each other. Sadly over the years this has changed with the huge increase of large truck traffic on Airport Road and the construction of residential housing, with more to come on several sites throughout the village. Along with this, the 'downtown' of the village around the Post Office and Liquor Store has deteriorated to such an extent that it can only be described as appearing neglected and totally ugly. The addition of a drive-through Tim Horton restaurant will only serve to add to the traffic density from the drive-through traffic and potentially lead to dangerous parking by truck drivers seeking their coffee and washroom breaks. In addition, we all know that a huge amount of the garbage found on our sideroads are Tim Horton's coffee cups and food packaging. Is this really what we want?? I think not. The garbage in the downtown of Caledon East is substantial already, including, since the onset of the Coronavirus pandemic, discarded masks and rubber gloves. Imagine the increase in Tim's coffee cups and other such food and beverage containers.

I walk my dog every day through the downtown of Caledon East and cringe on a daily basis as the condition deteriorates almost daily.

My other thoughts relate to the existing businesses in town such as Four Corners, Gabe's Bakery and Tom's Family Restaurant, all of whom serve a similar menu to what Tim Horton's will be offering. I would not want any of them to go out of business because of the arrival of a large national chain. I am not against Tim Horton's as a business and in fact use the restaurant from time to time when I am on a road trip, however, downtown Caledon East is definitely not an appropriate place to locate this restaurant.

My vote would be decisively NO to amending the Official Plan and Zoning By-law Amendment to allow the construction of a Tim Horton's Restaurant.

I have been a resident of Caledon East for 33 years. I moved here because I wanted to live in a small village which Caledon East was years ago. Like previous residents I was satisfied with the services provided.

I have participated in the process of creating the Official Plan for the Town as well as the same for Caledon East. It was decided years ago that 'drive through style service' was not a desirable thing for the village. Public officials took notice and a bylaw was passed – no drive throughs allowed.

I have read the applicants consultants report and could find nothing that would warrant a bylaw amendment for this project.

Weston Consulting is very good at flowering up the facts but we do not need another coffee shop in the village. We have three small business establishments that can serve coffee/baked goods already so what benefit is there to adding another one? A commercial one at that. Lets try to preserve what little rural services we have left in Caledon East. I am sure adding a Tim Horton's would not add to the rural character of the Village which has been in decline for years.

Caledon East can barely handle traffic volumes during peak hours now. Adding a drive through restaurant at this location would only add to the masses of cars backing up through the village. Just adding one transport truck parked along Airport Road, illegally as I am guessing the no parking/stopping signs would bloom near the location, to the drive in queue interfering with north/south bound traffic would mirror problems seen at/near other fast food establishments throughout the town. It is tough enough getting through the village on a regular 'rush hour' now. I can't imagine what it would be if this project is allowed.

This letter is my official opposition to the proposed official plan and zoning amendments for 16054 and 16060 Airport Road. (File Number POPA 19-07 and RZ 19-10)

When my wife and I purchased our home in 2015 I reviewed the town by-laws for village commercial properties, we felt safe in making the purchase with the prospects of bordering the listed establishments under that property zoning. This proposed Tim Horton's drive through will virtually be in our backyard. The proposed drive through and ordering speaker will border on our back fence with vehicles idling and placing orders day and night. This establishment will bring unwanted noise, litter, pollution and traffic safety issues to the area. The intersection of Airport and Old Church is a current major issue of concern for residents and this drive through service would only add to this problem. With the proposed location there will be further traffic funnelling down Walker Rd as well as other residential streets to avoid the congestion that this drive through would bring to the core of Caledon East. When you look at the locations of other drive throughs they all have multiple entrances and many with a forced entrance from a neighboring street which is not the main traffic route, and many with medians at the exits to only allow patrons to leave/enter in one direction only. None of this is satisfied and will never be satisfied with the proposed site location. The negative environmental impacts of drive through businesses are increasingly being recognised throughout Canada, and with Caledon recently declaring a climate change emergency I feel we should be upholding our current by-laws and not allowing such businesses. Together with a consultant we reviewed the proposed Tim Horton's drive through site plan and found numerous issues with the layout, proposed site location, and many contradictions to the towns official plan. Our findings are outlined below:

Current/future proposals in Caledon East need to consider what the town is projected to do to enhance the area/streetscapes. Road widening, and landscape areas on the major road is something that will be required for proposed developments. Based on the current proposal for the Tim Hortons coffee shop, many major issues arise that involve the Zoning by-law and Town-Wide Caledon guidelines.

# Issues with Tim Hortons Proposal based on Town-Wide Design Guidelines/Caledon East Guidelines

#### 11.2 Site Planning

The building is not oriented with the frontage. That is desired by the city based on their



planning guidelines. Refer to figure 3.

There is no consistent street edge in the area. Once the area further develops and road widening is required, the parking and drive-through area will be close to the road curb. Landscaping will become an issue as the Town of Caledon's design guidelines require a 2.00m

landscape area between parking area/roadway/building and the street.



Since Airport road is a major road, the town will not be able to plant trees and follow their own guideline when it comes to planting on the major road.

The Town of Caledon prefers parking on the side and rear of the building. The drive through area (which is not permitted) will create parking issues

once the city widens the road. Refer to figure 4.


There is no snow storage noted on the site plan which will have major affects in the winter with regards to adequate parking and function of the proposed site.

This development backs onto a very quiet residential core which be greatly affected by idling and noise pollution created by the drive through at all hours of the day extending greatly beyond what is considered normal working hours.

Noise generating areas, including ordering board speakers, outdoor loading area and garbage area will greatly interfere with the surrounding residents. The proposed development should be away from sensitive uses such as residential areas. The current proposal backs onto residential detached dwellings.

#### 11.2.2 – Site Circulation

Single point of access to the destination is required. When the city widens the road, the drive through area would likely require its own point of exit. The turning radius of the vehicle (based on the current plan) would likely require the driver to cut into the left lane if the driver is going south on Airport road. Creating a separate exit for the drive-thru will create confusion amongst



drivers entering the establishment. Refer to figure 5.

#### **11.2.3 Parking**

Truck access routes and loading areas should be located away from pedestrian routes. The current proposal does not compensate for trucks with trailers unloading daily stock for the establishment. The truck would have to back into the property to avoid interfering with

pedestrian routes which would not allow vehicles to enter/exit while truck is unloading as the lane way is only 2 lanes wide. An effective access route for the truck would require the removal of the drive through service (which is not permitted).

#### 11.2.4 Loading and Servicing

Loading and unloading of daily stock or materials should be away from the major road so nobody can see it.

The visual/functional impact should be minimal on site. The current scenario will create a significant impact when entering and exiting the establishment.

#### 11.2.6 Site Lighting

There will be a lot of lighting required involving a development like this. Based on the current plan, a lot of light will be crammed in to make fit on the site. The frontage will have at least 3-4 signs indicating enter, exit, drive-thru exit, and the generic Tim Hortons Pylon sign. With the location of the drive through there will be excess light spilling beyond the property lines into the homes and yards of the adjacent residential homes.

#### 11.2.7 Signage and Display Areas.

The proposed generic pylon sign is discouraged from use. It will likely not comply with the historical value that the city wants to maintain.

#### 11.4 Priority Lot

The lot is not big enough to make it comply with lots fronting on a major road.

#### <u>11.5.1 – Typical Internal Streetscape</u>

With the road widening noted on the drawings, a future universal sidewalk will not work with the proposed drive through. With the road widening the landscape buffer zone will be completely lost and set a precedent for future developments along Airport Road.

#### 11.5.3 – Site and Building Entrance

No decorative features proposed to the site entrance. The entrance will be cluttered with enter an exit signs. Entrances should be enhanced with trees and shrubs, not just grass alone.

With the current proposal, the road widening will require the removal of the landscaping area.

My name is Tyler Schiller, I live at: 29 McCaffery's Lane, Caledon East, Ontario L7C 1K4 I am in opposition to the proposed official plan and zoning amendments for 16054 and 16060 Airport Road. (File Number POPA 19-07 and RZ 19-10)

When my wife and I purchased our home in 2015 we reviewed the town by-laws for village commercial properties, we felt safe in making the purchase with the prospects of bordering the listed establishments under that property zoning. Never did we consider that neighboring a drive through service was even a possibility given the fact that they are prohibited under long standing current town by law.

I would like to make reference to a study completed by the Town of Caledon in 2012 that studied drive through services in Caledon and analyzed future areas to consider and prohibit such establishments. Not only did the study determine that drive throughs are to remain prohibited in Caledon East, they went as far as to state areas to never consider for drive throughs. To quote the report from 2012 regarding drive throughs in Caledon East "Although Caledon East is designated a Rural Service Centre it maintains a unique village character with a historic main street. A drive-through service facility, would negatively impact the unique character of this settlement. Drive-through service facilities should not be permitted along Airport Road or Old Church Road within the settlement or immediately outside the settlement boundaries. Drive-through service facilities should not be located adjacent residential properties". So to sum this up, this application is being proposed on Airport Road within the settlement, adjacent to residential properties. This is the exact location in which the town study determined should not even be considered for such establishments.

There are multiple issues with this application and their site plan and I would like to bring some of these issues to light:

- The applicant should be showing internal road connections to adjacent lands for future development. As the strip continues to develop it is critical that multiple establishments share the same access/ egress points onto Airport Road to avoid having the whole strip cluttered with driveway after driveway for traffic logistics and this would also make the downtown core unwalkable from a pedestrian safety perspective.
- Restricted move access to this property would seem to be essential to ensure proper traffic flow based on other drive through services in Caledon like Charleston Sideroad/ Highway 10 and Highway 50/ King Road in Bolton for example. Drive through services like these 2 examples have access points from at least 2 sides of the property with restricted move accesses for proper traffic flow/ funneling and pedestrian and vehicle safety. Access would likely have to be restricted to southbound traffic only in and out with this subject property, due to the only vehicular access being in the east property line.

Northbound traffic would be forced to make U turns or use the residential streets north of this property to turn around on. This will inherently cause further pedestrian safety and traffic issues.

- There is no escape lane which is a requirement for emergencies and the delivery access zone is not sized appropriately and inaccessible when drive through backs up. The current proposal does not compensate for trucks with trailers unloading daily stock for the establishment. The truck would have to back into the property which would completely block Airport Road while attempting to make such a maneuver. Once the truck was on the premises it would be blocking the parked vehicles from pulling out of the designated parking areas.
- The queuing lane and ordering speaker is abutted against 3 residential property lines. Excessive emissions, light and noise will be emitted onto these sensitive use properties and effect our quality of life. We will have small children and will not want them to be playing in the backyard breathing in all of the constant emissions from the drive through.
- When the town widens the road, the drive through area would likely require its own point of exit. The turning radius of the vehicle (based on the current plan) would likely require the driver to cut into the left lane if the driver is going south on Airport road. Creating a separate exit for the drive-thru will create confusion amongst drivers entering the establishment and would further add to the issue of having too many access points onto Airport road.
- -With the road widening noted on the drawings, a future universal sidewalk will not work with the proposed drive through once the road is widened. With the road widening the landscape buffer zone will be completely lost and set a precedent for future developments along Airport Road. In short, this lot is not even close to big enough to make it comply with lots fronting on a major road as outlined in the official plan.
- -The applicant has shown no areas for snow storage, further highlighting the fact that is property is too small. Here in Caledon we are in the snow belt as all residents know, the snow would need to be plowed into the parking areas (reducing onsite parking) to keep the property functional during snowfall periods. During larger snowfalls the snow would likely need to be trucked out causing further congestion and safety issues in the main core.

On a more personal note, this property backs directly onto our yard as well as 2 others. I would like to point out that this is not a single poorly placed residence as sometimes seen when areas redevelop, this is an entire residential street that with be directly affected if this application is approved. Up until now it has been a quiet peaceful street. If a drive-thru is allowed, we expect the area to be affected by the noise from a line up of idling cars, ordering board speakers, loading and unloading of trucks and the smell of dumpsters and exhaust. We imagine that these effects will be felt at all hours of the day extending greatly beyond what is considered normal working hours. Even the lighting needed for the drive through will spill over onto our property/ house and through our windows. We expect an increase in traffic on our cul-de-sac as well. Overall, we expect an approval of this application to carry negative financial implications to multiple surrounding residential dwellings in the area.

Any approvals and provisions given to this establishment will set precedent for all future applications. It is critical that all factors be taken into consideration when assessing this application. If this application is approved it will lead to the destruction of the vision that the town has set out in its plan.

Overall, an approval of this application will negatively impact ourselves, other residents, as well as the local businesses, traffic flow, air quality, parking, pedestrian safety, and cleanliness due to litter. The intersection of Airport Road and Old Church is a current major safety issue of concern for residents and this drive through service would only add to this problem. The applicant does not meet even the basic requirements of the official plan and has overlooked multiple on site requirements for such an establishment. In short, this lot is too small to properly accommodate such an establishment, in a very busy area, backing onto a quiet residential street and will cause traffic and pedestrian disruptions, noise, litter and will scar the unique character of Caledon East. This proposed site would be an absolute nightmare for our town on so many fronts and should be denied the requested amendments. The negative environmental impacts of drive through businesses are increasingly being recognised throughout Canada, and with Caledon recently declaring a climate change emergency and recently enacting a very ambitious plan to reduce greenhouse gas emissions to a net zero in the coming years, it would seem counterproductive to amend current bylaws restricting such greenhouse gas emitting establishments. I feel we should be upholding our current by-laws and not allowing such businesses.

Thank you for your time in reading my comments, I trust that the Town of Caledon, Region of Peel, and elected Town Councillors collectively will make the right decision regarding this application.

### Re: My Comments Regarding Proposed Official Plan Amendment and Re-Zoning Application for 16054 and 16060 Airport Road (Ward 3)

Thank you for this opportunity to comment on the above Application, which involves the construction and operation of a Tim Horton's restaurant that includes a drive-through feature. Please consider this letter as my submission of my comments.

Unfortunately, the proposal regarding the Tim Horton's restaurant is problematic for the following reasons:

- The standard characteristics and features of the Tim Horton's franchise likely will take away some business from the existing small bakeries and restaurants within Caledon East.
- 2. Due to inevitable human nature and behaviour and I wouldn't blame anyone for wanting to do this there will be the temptation and actual commitment of parking transport trucks and other varieties of large vehicles along the sides of Airport Road north of Walker Road, in order to use the Tim Horton's restaurant as a "pit stop". This kind of parking will not be safe for other drivers in the area, such as those wanting to turn onto Airport Road from Walker Road or Leamster Trail, nor would it be safe for pedestrians, including the truck and other large vehicle drivers themselves.
- 3. The increased traffic may end up forcing the Town of Caledon and/or the Region of Peel to install either 4-way stop signs or traffic lights at Airport and Walker Roads intersection, and may also force the installation of a pedestrian crosswalk, such as found at the Caledon Trailway. These features may not be bad things in and of themselves, but the Town or the Region may not be prepared financially to foot the bill(s) for these installations.
- 4. Tim Horton's popularity and drive-through feature will disrupt on a consistent basis the pedestrian feature afforded on Airport Road as part of the Caledon East village environment, since a significant number of Caledon East villagers walk along Airport Road on a daily basis. Also, next to and along that particular location, during 5 to 6 months out of the year, customers use the sidewalk to line up to buy ice cream and other foods from the Main Street Ice Cream Shop that is immediately next door on the north side.
- 5. While the Tim Horton's restaurant itself has an attractive look, the restaurant will look and feel out of place next to all the other Heritage buildings surrounding it.

6. The Tim Horton's restaurant will destroy the Heritage buildings currently on each site. These properties could be repurposed in ways that can still bring some profit to Ganni Properties Inc., or, the Tim Horton's restaurant could be adapted creatively to the Heritage buildings. If the drive-through feature is eliminated as well, then many of the concerns and issues would be resolved immediately.

#### Some Possible Alternate Ideas:

- A. As mentioned in point number 6. above, use the current Heritage building(s) on the property to house the restaurant and eliminate the drive-through. Add outdoor patio and/or place picnic tables outside.
- B. Consider other commercial or residential uses for the two properties, such as repurposing the Heritage buildings for either...
  - i. Housing for seniors,
  - ii. General store,
  - iii. Local farm foods store. Perhaps team up with Town of Caledon's Evolve Stores to create "Evolve Farmcrafts / Evolve Farmgoods", or another name, that will feature local and regional produce, groceries and foods, and perhaps Canadian arts and crafts, year-round, on consignment, with half of proceeds benefitting Caledon Community Services, or
  - iv. Doctors' or other healthcare professionals' office(s).

These are my thoughts. My feelings are that I would rather support the existing bakeries and restaurants, and I would love to see a local and regional produce and farm goods store within walking distance of me. I could and would make good use of that year-round as my mom and I like to buy from local farmers and food producers.

Thank you once again for the opportunity to comment on this Application.

Dear Mrs. Mohanadas,

My wife, Heather Watson, and I oppose the amendment to re-zone subject lands located on 16054 and 16060 Airport Road in Caledon East Village from Village Commercial to Village Commercial Site Specific Exception and to amend the Town of Caledon Official Plan for the purpose and effect to permit a Drive Through Service Facility associated with a Restaurant (Tim Horton's) and other site works.

We have four major concerns:

- 1) Traffic The flow of traffic through Airport Road would be greatly impeded by vehicles turning into and exiting of the proposed drive-through. This would lead to increased and even extreme traffic congestion, decreased pedestrian safety, and an overall unfavourable affect on the standard of living in our town.
- 2) Impact on existing businesses Our town already has two locally-owned coffee shop style restaurants (Gabe's and Four Corners) and a locally-owned restaurant (Tom's.) A Tim Horton's Drive through is both unneeded and unwanted by most Caledon East residents who prefer to support their existing restaurants. Residents currently benefit from choice; a Tim Horton's drive through would put undo strain on the existing business and threaten to reduce our choice and again diminish our overall standard of living. We residents of Caledon East view these businesses as both our neighbours and friends.
- 3) Impact on Residential Area My neighbours and I live on the properties directly behind the proposed drive through. The official plans have the drive through running parallel only feet from our property line with a speaker-box very close to our backyards. The constant sound of idling cars, people shouting into a speaker box, and garbled responses from employees would not be commensurate with residential zoning. The exhaust and overall commercial feel it would impose on existing residents would not be in keeping with a family neighbourhood and would greatly reduce property values in the area.
- 4) Environmental Impact & Small Town Charm A Tim Horton's drive through would add to air pollution from idling vehicles and garbage waste in Town. Residents of Caledon East do not want our Town to become strewn with infamous Tim Horton's litter and have a constant line vehicles emitting exhaust. In this time more than ever, we should be aware of the rising climate emergency and act responsibly. We currently have a unique Town; locally owned businesses with little garbage and large commercial chains. We understand the need for development on Airport Road but a Tim Horton's drive through would only denude our town our uniqueness and turn our town into a "gasoline alley" for motorists passing through. We reject the homogeneity of Tim Horton's towns.

I strongly urge The Town to reject this amendment and consider the wishes of the actual people of Caledon East who are the foundation of our community and do all the living, child raising, and tax-paying in this Town.

My objections to the application are 1) the location, and 2) the effect on local eateries in the area.

# Property 16054 and 16060 Airport Road

To the Planning Board,

I have not participated in other changes to the official plan in the past, but this has caught my attention.

Let me start by stating this an incredibly bad idea and let me tell you why in the following points:

My understanding is that the Town of Caledon is known as one of the greenest towns in Ontario. Please tell me how putting a satellite Tim Hortons in the middle of a small town with the potential non-stop parade of idling automobiles waiting to get coffee and take-out food is by any stretch of the imagination a "green" idea. My guess is that you must be aware there is a climate and environmental crisis in the works.

From my observations of satellite Tim Horton drive throughs I've witnessed in Toronto, their impact is a disaster on traffic

flow. Let me make you aware of at least 3 locations that I'm aware of:

- 1. South side of Wilson one block west of Dufferin it is a daily occurrence (particularly in the mornings) that traffic from Tim Hortons has spilled out onto Wilson and blocked eastbound traffic. The traffic entering the Tim Hortons is coming from eastbound traffic as well as westbound traffic (making a left turn to get to the drive through).
- 2. South side of Dundas Street 2 blocks east of Jane Street idling vehicles waiting to get into the drive through backed out onto a main road blocking traffic flow.
- 3. North side of Albion Road just west of Islington Ave. idling vehicles waiting to get into the drive through backed out onto a main road blocking traffic flow.

My understanding is that one of the main criteria to having a profitable drive through/take out establishment is speed of service. My observation of the proposed location is that there is a lot of pedestrian activity throughout that area.

There is an ice cream stand just north and a newly opened restaurant just south. I've noticed many families out for a walk, people walking their pets, and students all enjoying the pedestrian friendly atmosphere of Caledon East.

The idea of having vehicles idling and rushing in and out with their orders and potentially slowing traffic flow on Airport Road as part of the relatively quiet and non-bustling town of Caledon East is a poor proposal for the kind of town probably most people in the area would want to raise their families in.

Bolton would be an example of what happens to the downtown core of a historic Ontario town that didn't take into account the long-term development of a small town. One of the blatant observations of the failures of Bolton is the number of vacant retail spaces in the downtown core and how long many of them have been vacant because of the transient nature of the planning.

Hopefully, you will find this input useful and you will seriously consider all the long term issues a decision like this **COUId bring forth.**


As a resident that lives near the proposed site, I am concerned about this location for three reasons:

I am providing this written comment in support of the Zoning By-Law to permit a drive through Tim Horton's in Caledon East on Airport Road.

As a resident of Caledon East for 7 years, it is clear that the community is growing and changing. The town needs to adapt to meet the growing needs of the community and the rezoning would support that growth.

There are several reasons why a Tim Hortons Drive through facility would support the town's growth.

A new business would provide youth with job opportunities. I have three teenagers between the ages of 13 and 18 years of age. Since there is no public transportation in Caledon East, the town should be looking to create job opportunities for residents and not shutting down businesses that are looking to provide opportunities.
