7	9938 Columbia Way	Remains of pioneer cemetery	2020 –07	No heritage resources on property; municipal easement on property for access to adjacent pioneer cemetery is not considered a heritage resource
8	3852 The Grange Sdrd	c.1875–1899 Gothic Revival style farmhouse with synthetic siding	2020-91	Demolition sought through planning application prior to listing; heritage staff confirmed structure does not merit heritage designation due to extensive alterations
9	1460 Cataract Road	c.1875–1899 Late neoclassical house	2020-68	development permit application prior to listing; heritage staff confirmed structure does not merit heritage designation due to extensive alterations

10	16740 St. Andrews Road	c.1925-1945 1 1/2 storey farmhouse with 2 storey addition, with neoclassical elements	2020-91	development permit application prior to listing; heritage staff confirmed structure does not merit heritage designation due to extensive alterations
11	16771 St. Andrews Road	c.1900-1924 Edwardian classical style red brick farmhouse	2020-91	Demolition required as condition of NEC development permit issued prior to listing; owner intends to salvage architectural materials where feasible
12	20429 Willoughby Road	c.1850-1874 Neoclassical style house with board and batten siding	2020-07	Heritage staff confirmed structure does not merit heritage designation; owner to salvage historic materials for use in new house
13	3029 King Street	c.1900-1924 Ontario Cottage style with synthetic siding	2020-91	Notice of Intention to Demolish received October 13, 2020. Heritage staff confirmed structure does not merit heritage designation due to alterations
