PRESENTATIONS

Judy Mabee on behalf of the West Caledon Traffic Group provided a presentation to Council regarding noise concerns resulting from vehicular traffic. Ms. Mabee stated that the increase of vehicles with modified mufflers and stunt driving activity on residential roads is negatively impacting the quality of life for Caledon residents. She provided an overview of the community Groups' recommendations for increased enforcement and penalties for drivers that are caught stunt driving and causing a noise disturbance within residential areas. Ms. Mabee concluded the presentation by requesting Council take action to reduce stunt driving and increase enforcement for excessive noise caused by vehicles with modified mufflers.

Members of Council asked several questions and received responses from Ms. Mabee.

That as part of the Town's Marketing Campaign related to tourism, a focus be placed of shifting visitors away from high traffic areas and developing a visitor guide that outlines polite and respectful behaviour;

That the Caledon OPP be encouraged to investigate the feasibility of implementing the Peel Police Noise Maker Project in Caledon by January 2022 and to encrypt or prevent the interception of their communications when responding to street racing by January 2022,

That Town Staff be directed to work with Peel Region, in consultation with Caledon OPP, to conduct a fulsome review of traffic management within the villages on the west side of Caledon to determine options that could be considered to mitigate noise resulting from vehicular traffic within the area, including but not limited to, Highway Traffic Act section 75(1) and 75(4), automated speed enforcement cameras and acoustic traffic cameras; and

That a copy of this resolution be provided to Inspector Garant, Caledon OPP, Peel Region and the West Caledon Traffic Group.

Carmel Hili and Rie Elemaolie on behalf of the Social Justice Committee, Holy Family Church in Bolton provided a presentation regarding Low Income Housing for Caledon Families. Ms. Elemaolie stated that the Town of Caledon has a shortage of low-income housing and affordable rental units for families. She stated that access to affordable housing creates stability for families experiencing financial hardship. She advised that the Town requires a greater variety of housing options, specifically more low-rise apartment buildings. Mr. Hili stated that low-income housing needs to be incorporated into all future developments within the Town to address the growing need. Ms. Elemaolie concluded the presentation by stating that access to affordable housing is a fundamental necessity and needs to be addressed within the Town.

Members of Council asked several questions and received responses from Ms. Elemaolie and Mr. Hili.

Mayor A. Thompson thanked Mr. Hili and Ms. Elemaolie for the presentation.

Kim Delahunt, President and Chief Executive Officer, Headwaters Health Care Centre, provided a presentation regarding the Headwaters Health Care Centre and Ontario Health Team Collaborative. Ms. Delahunt provided a brief overview of the Headwaters Health Care Centre's response to COVID-19. She highlighted the core services and programs provided by the Health Care Centre to the residents of Caledon. Ms. Delahunt concluded the presentation by highlighting the recent improvements to the Health Care Centre and planned upgrades for 2021.
