## THE CORPORATION OF THE TOWN OF CALEDON BY-LAW NO. 2021-XXX

Being a by-law to amend Comprehensive Zoning By-law 2006-50, as amended, with respect to PT LT 10 CON 2 ALBION AS IN AL21719 TOWN OF CALEDON, Town of Caledon, Regional Municipality of Peel, municipally known as 6939 King Street


