Dr. Robert Williams and Jack Ammendolia of Watson & Associates Economists Limited, provided a presentation regarding the Ward Boundary Review project. Mr. Ammendolia provided an overview of the proposed ward boundary system identified as Option 1, along with three (3) modifications identified as Options 1A, 1B and 1C. He concluded with a summary of the proposed modifications and any corresponding impacts to the guiding principles.

Members of Council provided comments and asked several questions regarding the proposed ward boundary options, and received responses from Dr. Williams, Mr. Ammendolia and staff.
