Please state the purpose of the request to present (identify the subject matter to be discussed and any other relevant information):

My partner (Shane Clarke) and I is interested in opening a retail Cannabis Store in Bolton. We are aware that this was previously discussed and declined at Council, however, given that this debate and decision was made just as Cannabis was legalized in Ontario, I believe that council placed a lot of emphasis on the report from the OPP. This report outlined the expected impact of a cannabis store in the region. The challenge is that there was no empirical evidence in Canada and as such, the OPP had to use external data and speculations. Given that a number of years has passed we are asking if council could reopen the debate or have a new debate on the subject. There is a lot of data now available to help council in taking a second look. Much like the OPP and council, we are concerned about operating in a safe and secure environment, we do know that the consumption of Cannabis is on the rise in Caledon so that would mean, the residences are either going outside of Caledon to procure it or they are getting it illegally in Caledon. We are looking to establish an entity that will work with the OPP to ensure a safe place that will abide by all requirements from the Federal, Provincial and Municipal Governments and the Opp and RCMP.
