Heritage Caledon Subcommittee

a) Research Subcommittee

V. Mackie informed the Committee that the Bolton bicentennial commemorative plaque is now completed and that the bicentennial celebrations for all villages with the exception of Caledon East are tentatively planned for 2022. V. Mackie informed the Committee that the Caledon East bicentennial ceremony is scheduled for October 23, 2021 and will be combined with the 2021 Caledon Walk of Fame dedication ceremony.

Staff clarified that the 2021 Caledon Walk of Fame dedication ceremony is tentatively scheduled for October 23, 2021 based on the availability of the Walk of Fame candidate to be approved by Council at the September 28, 2021 Council meeting.

Orange Lodge

H. Savage, Director of Community Services introduced T. Darlow, Manager, Corporate Facilities, to provide the Committee with an overview of staff's recommendation to re-erect the Orange Lodge on the Caledon East Community Centre campus as a skating shelter. T. Darlow informed the Committee that the proposal recommends using the original timber frame beams and roof structure along with asphalt shingles to build a skating and picnic shelter. The shelter would be located next to the proposed outdoor rink and would be accessible through a network of sidewalks.

Bolton Downtown Revitalization Task Force

D. Paterson informed the Committee that the Bolton Downtown Revitalization Task Force has met twice and discussed options for the old Bolton Fire Hall.
