Letter of Support for Memorandum 2022 -0028 Age-Friendly Caledon Action Plan - Annual Progress Report - 2021

Dear Members of Council,

We, the members of the Seniors Task Force, have provided this letter in support of memorandum number 2022-0028, the Age-Friendly Caledon Action Plan Annual Progress Report for the Town of Caledon, provided at the General Committee meeting on February 15, 2022. We believe that the adoption of the Age-Friendly Caledon Action Plan (the plan) by Town Council in the spring of 2021 was a pivotal moment not only for older adults but for all Caledon residents.

We are the living memories of the community, and we remind our citizens and decision-makers that all of us hold the welfare of the future generations in our hands.
