UPDATES

Heritage Caledon Research Subcommittee

a) Village Bicentennial Project Update

V. Mackie informed the Committee that the Research Subcommittee is working on the draft plaque for the village of Cheltenham. She advised that the plaques for the villages of Caledon East and Bolton are complete. She concluded the update noting that the plaques for the villages of Alton, Caledon Village and Campbells Cross are still to be completed.

B. Early-Rea advised the Committee that the plaque for the village of Sandhill is still to be completed.

Chair J. Crease informed the Committee of the upcoming bicentennial dates for 2022. She noted that the bicentennial for Caledon East is scheduled to take place on May 7th, Bolton is scheduled to take place on June 4th and 5th and Cheltenham to be confirmed in July.

b) Village Walking Tour Update

B. McKenzie informed the Committee that the Town of Caledon launched a Tourism webpage. She advised that the webpage includes information on the walking tours. Ms. McKenzie raised concerns regarding the limited access to information on the webpage via search engines and the errors on the banner page. Concerns will be shared with Town staff, with the suggestion that staff consult the committee on future website updates.

a) 2022 Heritage Caledon Committee Budget

S. Drummond informed the Committee that the 2022 Committee Budget for their expenses is a total of \$5000.00. She highlighted that for Committee Events, there is a cumulative budget of \$35,000.00 to host the seven bicentennials in 2022. She highlighted that the cumulative budget includes carryover amounts from 2020 and 2021.
