## Neighbours Of Boston Mills Road Petition For A Safter & Cleaner Community Purpose and Letter of Intent

To the Town of Caledon, including but not limited to; Mayor Allan Thompson, Councillor Downey and Councillor Early,

In the past two years our neighbourhood, which includes a section of Boston Mills Road between Highway 10 and Dixie Road, has witnessed an increase in visitors and with-it undesirable behavior. Some of this behavior includes:

- 1. Increased dumping of hazardous materials, household materials, organic materials, and general refuse.
- 2. Increased speeding and reckless driving at times making it dangerous to drive on, walk and enjoy the road.
- 3. Increased stopping/idling on the road to loiter, litter, and participate in undesirable activities (drinking, smoking cannabis and "bush sex" among others).

Some of these visitors have become very hostile when approached and asked to move on, leaving our community members feeling unsafe and fearful. Many members of our community have voiced their concerns to each of you and the Town of Caledon. Others have spent their time picking up the garbage and trying to take matters into their own hands. Many members of our community have young children who should not be witness to these activities, nor at risk of getting hit by speeding cars.

As a community, we feel that it is time that some concrete action be taken to address our concerns and eliminate this unwanted behavior. We propose the following changes to our specific section of Boston Mills Road between Heart Lake Road and Dixie Road:

- 1. NO STOPPING signs installed along this section of road;
- 2. Speed limit reduced from 60km/hr to 40km/hr along this section of road;
- 3. Additional NO DUMPING signs installed along this section of road; and
- 4. Other means of detering the parking of cars, e.g. narrowing of the the road along this section

We appreciate your efforts thus far to increase the police presence in our neighbourhood. However, unfortunately it has done little to reduce any of our concerns. We believe that having these additional measures in place will dissuade visitors from using the road as a city dump, a place to illegally idle, a location to stunt drive as well as the other aforementioned behavior.

Please see below for a petition of our neighbours and community members insisting for these changes. Thank you in advance for your immediate attention to our concerns and immediate action towards creating a safer and cleaner community for all of us in the Town of Caledon.
