DELEGATIONS

Ruth Wheelwright provided a delegation regarding agenda item 12.1 BL-2022-022 being a by-law to regulate and prohibit the sale and discharge of fireworks. Ms. Wheelwright discussed her experiences within the community and with hosting events. She expressed understanding for others concerns relating to fireworks but stated that education and guidelines are better for addressing those concerns. Ms. Wheelwright indicated that the proposed by-law is too restrictive.

Perry Logan on behalf of the Canadian National Fireworks Association provided a delegation regarding agenda item 12.1 BL-2022-022 being a by-law to regulate and prohibit the sale and discharge of fireworks. He indicated that the proposed by-law would limit the fireworks industry and impact jobs. Mr. Logan expressed concern regarding the impact that the proposed by-law would have on the community. He proposed that education is a better tool for addressing resident concerns regarding safety and nuisance. Mr. Logan indicated that the Canadian National Fireworks Association has done further research on the impact of fireworks to animals including consulting with the humane society. He acknowledged that the Canadian National Fireworks Association now includes aspects pertaining to animal safety and comfort in their education materials. Mr. Logan named municipalities that include an education component at the point of sale. He concluded with a request that Council vote against the proposed by-law and conduct further public consultation to find an alternative solution.
