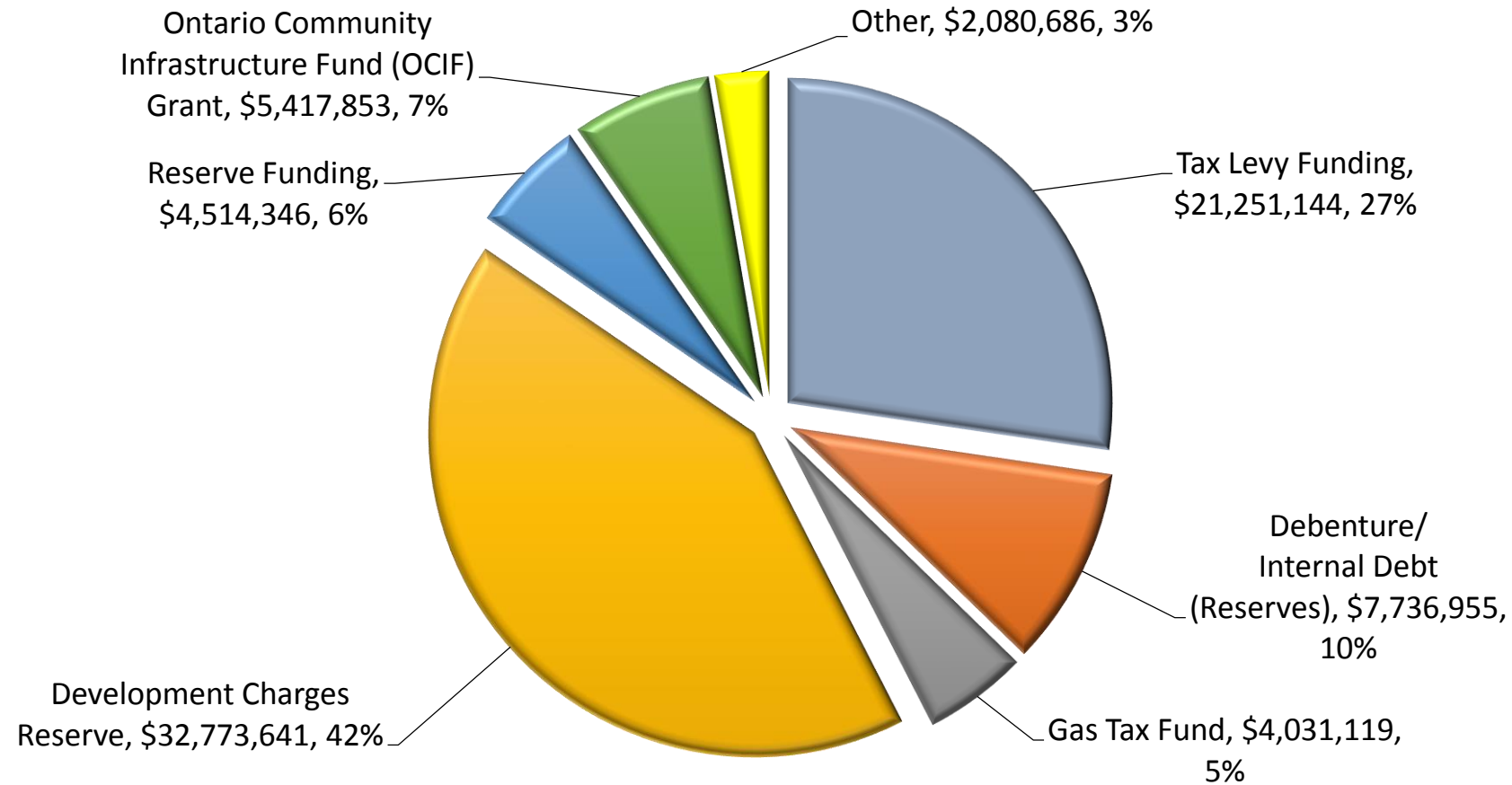

# Use of Reserves in 2023 Budget – Impact



- Reserves will be utilized to mitigate the impact on taxpayers of any one-time costs in the operating budget;



- Reserves will be used to assist with funding the Town's capital program to ensure adequate investment into Town infrastructure;



- Reserves will be utilized during 2023, subject to Council approval, if construction tenders come in over budget due to supply chain impacts or if any unexpected capital expenditures occur due to emergencies etc;



- Reserves will be utilized if any urgent priorities or opportunities occur the Town can be responsive in meeting the needs of the community



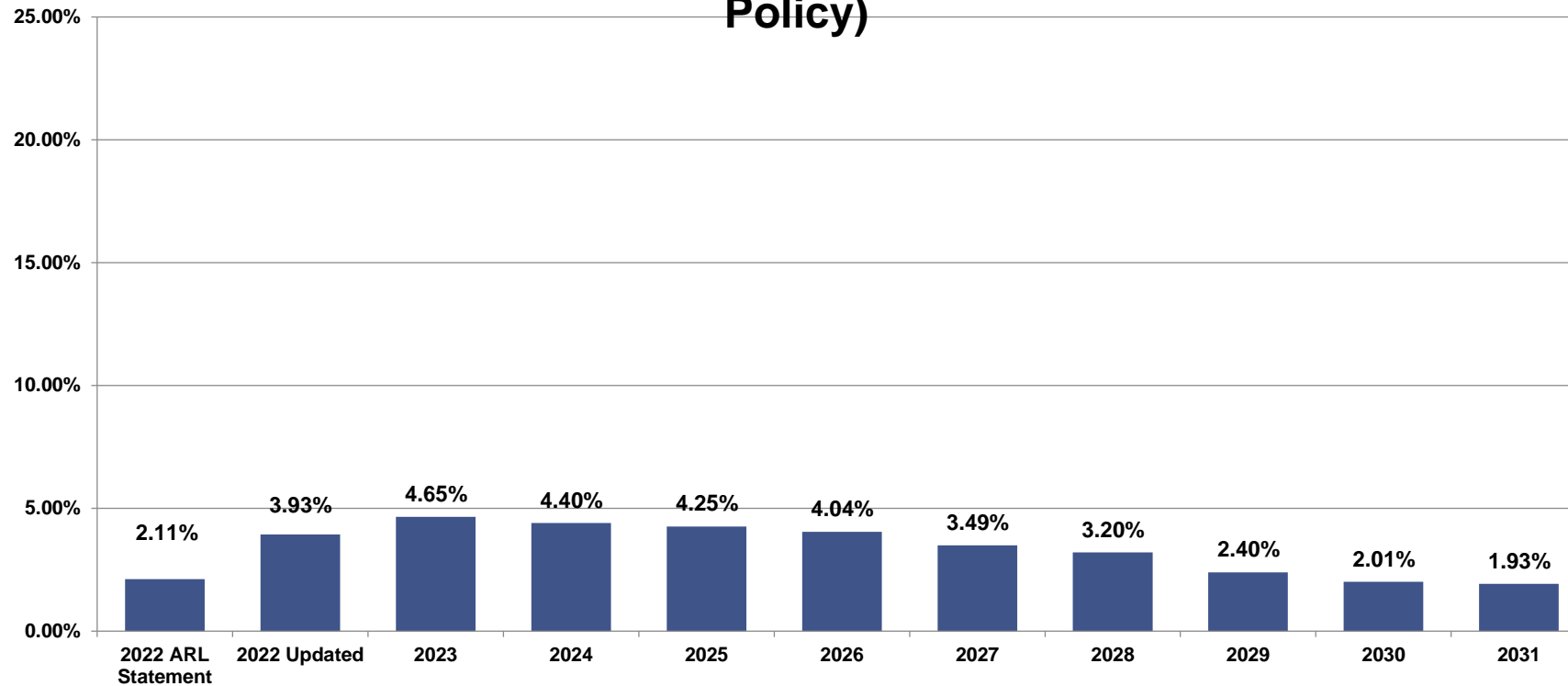

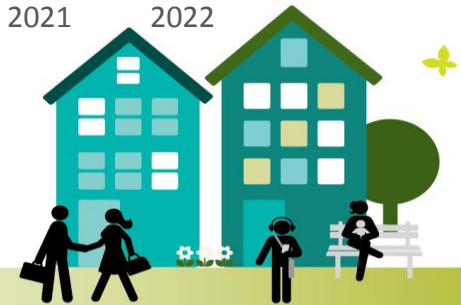

# What is Asset Management – Why is it important?

*“A business process – managing assets (infrastructure / equipment) that balances lifecycle costs, performance and risks against the desired performance of assets to achieve our Town objectives”*

*ROADS EXAMPLE: What the community expects and is willing to pay for?*

- As with all assets roads deteriorate over their life*
- Growing risks, negative customer service expectations occur*
- Require ongoing maintenance, capital restoration and replacement investments at the correct times ensuring the lowest possible lifecycle costs to maintain service levels*
- Investing at the wrong times or at the end of an assets life to only replace it will result in unnecessary high-costs plus customer dis-satisfaction.*



# Our Planned Asset Management (AM) Journey

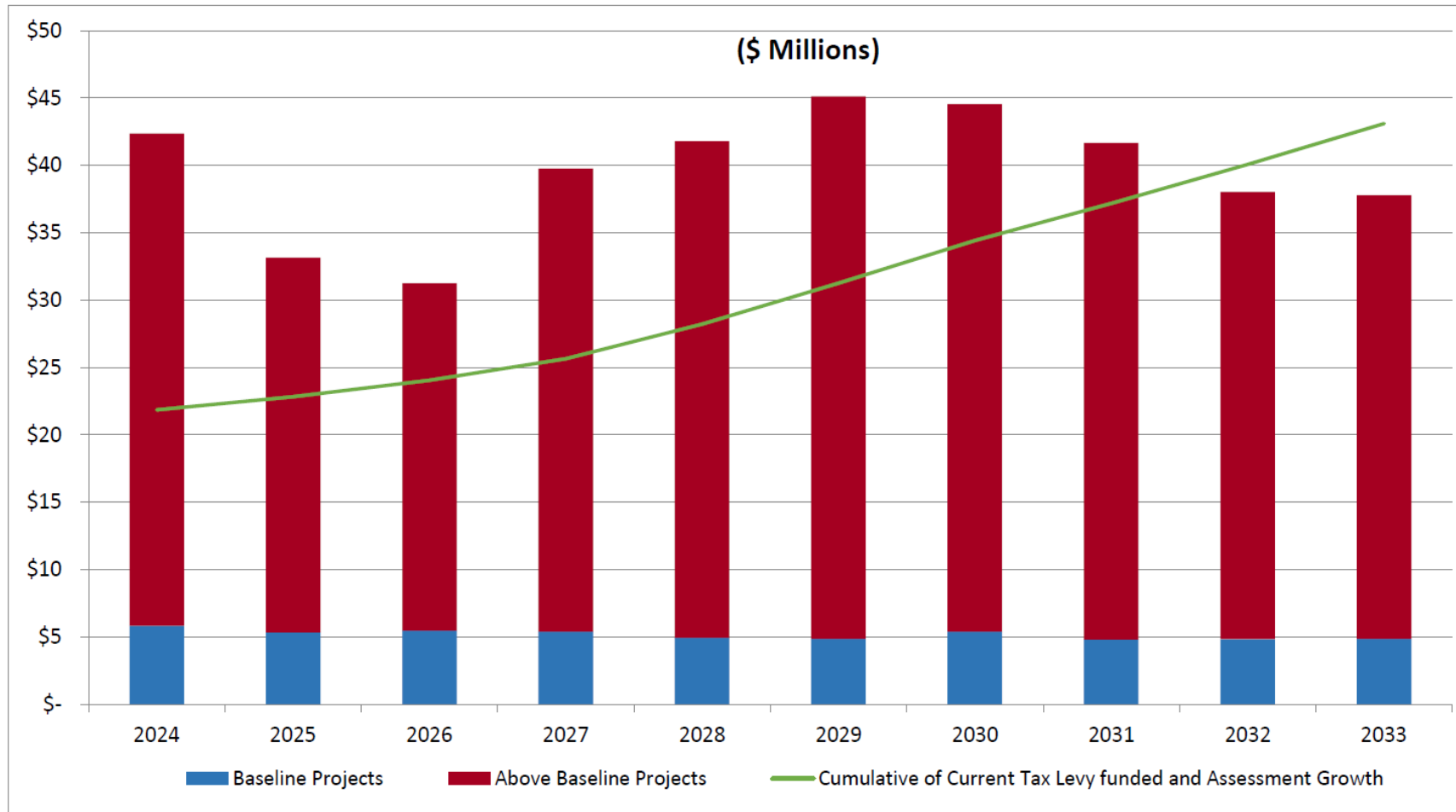
- *Implement AM business improvements across the Town to improve our Service Delivery “The value assets deliver to stakeholders” \*ISO 55000 AM Standard*
- *Achieving both O.Reg 588/17 obligations and Town wide AM continuous improvements with measurable benefits*

**ROADS EXAMPLE:** *What the community expects and is willing and able to pay for?*

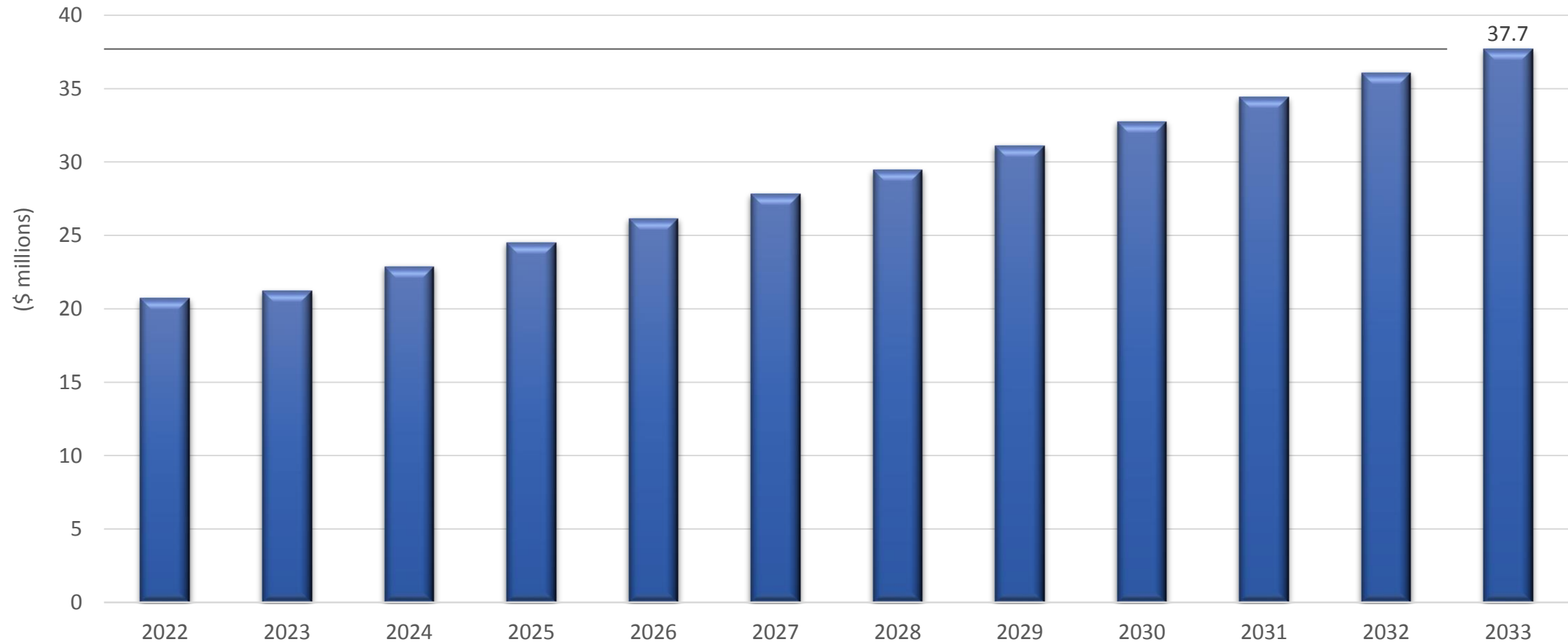
- *Improve asset registries to better manage assets*
- *Create levels of service with council focused on road rideability, our customers expectations, etc.*
- *Create an evidence-based AM program that informs decisions - make the right decisions, at the right time for the right reasons*
- *Plan for and know actual costs and performance of council approved levels of service for roads / all asset classes by July 2025*
