Subject: 2022 Annual Assumed Subdivision Status Report

This memo provides a summary of the subdivisions that were assumed by the Town in 2021 and 2022 and the associated infrastructure (roads, storm sewers, sidewalks and streetlights) that is now being operated and maintained by the Town's Operations Department. This information is being provided for consideration during the 2023 Annual Operating and Capital Budget deliberations.

Background

On a typical year, the Development Engineering Inspection's group is overseeing approximately sixty active subdivision and development related infrastructure projects. Once a development project has been satisfactorily completed, the municipal infrastructure may be assumed by the Town. Upon assumption, the Town is responsible for the life-cycle cost of the infrastructure including operating, maintaining and ultimate renewal.

In 2021, eleven subdivisions were deemed complete and assumed by the Town. Three of these subdivisions were developments that were essentially completed many years ago but never assumed by the Town because of missing paperwork or minor deficiencies. Practically, the Town has been maintaining these legacy developments for years notwithstanding they were technically not assumed. These are referred to in this report as "legacy subdivisions". In 2022, five subdivisions were assumed by the Town, two of which were legacy subdivisions. The following tables summarize the subdivisions that were assumed in 2021 and 2022 and the related estimated annual operating and maintenance costs.

In 2021, approximately 4.6km of public streets was added to the Town's inventory of infrastructure including the associated municipal services such as storm sewer, catchbasins, maintenance holes, sidewalk, street signage and street lighting (excluding electricity costs). In 2022, another 4.0km of public roadway was added to the Town's inventory of infrastructure. Combined, the annual operating and maintenance cost associated with this new infrastructure is approximately \$130,000.

Currently, there remains approximately forty-six additional un-assumed subdivisions at different stages of construction in the Town.

FINANCIAL IMPLICATIONS

The Town's annual operating and maintenance costs per kilometre of road (2-lane) is estimated at approximately \$15,000.00. Based on the addition of 8.66 kilometres of new road and associated infrastructure that were assumed by the Town in 2021 and 2022, the Town's Operations Department budget has captured the increase of \$130,000 to ensure minimum maintenance standards are being met. This has been submitted as part of the 2023 budget.
