ORIENTATION WORKSHOP

S. Drummond, Senior Heritage Planner, Strategic Policy Planning, provided an overview of the development of the Town's Heritage Resource Inventory and Cultural Heritage Landscapes Inventory. Ms. Drummond discussed the Town's Archeological Management Plan and demonstrated how Members can access the Heritage GIS Mapping system. Ms. Drummond discussed the Town's online Heritage Register and virtual Designation Story Map.

C. Jasinski, Heritage Planner, Strategic Policy Planning, provided an overview of the designation process for individual properties under Part IV of the Ontario Act. In addition, she noted what a Heritage Conservation District is under Part V of the Ontario Heritage Act. Ms. Jasinski discussed the Bolton Heritage Conservation District and the role of Heritage Permits.

Ms. Drummond and Ms. Jasinski provided an overview of recent amendments made to the Ontario Heritage Act through Bill 108: More Homes More Choices Act and Bill 23: More Homes Built Faster Act. Ms. Drummond concluded the workshop by discussing various types of education events held by the Heritage Caledon Committee.
