Whereas Mr. Wilson, a longtime resident of the Town of Caledon, member of the agricultural community and a true champion for the betterment of the Town, proposes a generous donation of a portion of his lands located at 13068 Humber Station Road, for the purposes of building a Fire Station and a Paramedic Service Station;

Whereas in 2021, Mr. Wilson generously donated approximately 20 acres of the noted subject property to the Region of Peel for a future healthcare centre;

Whereas the Town's Fire Master Plan indicates a need for the Town to build a new Fire Station on the south-west side of Bolton to service the area;

Whereas Mr. Wilson's lands are located in close proximity to the desired area for a future Fire Station;

Now therefore be it resolved that the Town of Caledon accept the land donation from Mr. Wilson of approximately 5 acres and staff be directed to work with Mr. Wilson to transfer the land into the Town's ownership, including any and all documents necessary to execute the transaction;

Further that once all documents are approved by the Chief Administrative Officer in consultation with the Town Solicitor and Supervisor of Realty Services, that staff provide a Memo to Council with details of the final land transfer prior to the Mayor and Clerk exercising their delegated authority to execute any and all documents deemed necessary to accept the land donation;

And further that any expenses, fees or taxes required to facilitate the land donation be paid from the Town's Operating Contingency Reserve.

#### **DELEGATIONS**

Ian Sinclair provided a delegation regarding the Memorandum: Update on the Ontario Land Tribunal Hearing for 0 and 18314 Hurontario Street in Ward 1. Mr. Sinclair expressed concerns regarding sewage treatment and sewage drainage within the area. He raised additional concerns around potential well pollution of private wells and the proposed developments site plan. Mr. Sinclair advised that in his opinion, the Town should seek more guidance from the Ontario Land Tribunal on the drainage and septic concerns within the application. Mr. Sinclair concluded his comments by suggesting the site plan approval be determined by Council.

Surat Atwaul provided a delegation regarding a Ministerial Zoning Order issued by the Province to the Rice Group for the property municipally known as 12245 Torbram Road, Ward 3. Mr. Atwaul expressed concerns regarding the notification provided to residents relating to MZO's and development projects within the community. He raised additional concerns regarding protentional effects on the community because of the development, including decreased property values and curbside appeal, and increased noise pollution and traffic. Mr. Atwaul inquired about next steps in the development plan and a timeline for public notification during each phase.

Bipanpreet Singh provided a delegation regarding a Ministerial Zoning Order issued by the Province to the Rice Group for the property municipally known as 12245 Torbram Road, Ward 3. Ms. Singh raised concerns regarding notification provided to residents relating to the MZO and development projects within the community. She raised additional concerns regarding potential noise and light pollution, compromised standard of living and decreased resale values of the residential properties in the vicinity of 12245 Torbram Road. Ms. Singh raised additional concerns regarding accountability and requested a pause in development until further information is provided to residents.

Prince Singh provided a delegation regarding a Ministerial Zoning Order issued by the Province to the Rice Group for the property municipally known as 12245 Torbram Road, Ward 3. Mr. Singh echoed the concerns raised by the previous speakers regarding notification provided to residents relating to MZO's and development projects within the community.

Nadia Capuano provided a delegation regarding a Ministerial Zoning Order issued by the Province to the Rice Group for the property municipally known as 12245 Torbram Road, Ward 3. Ms. Capuano echoed the concerns raised by the previous speakers regarding public notification of the MZO and future development projects in the community. She concluded her delegation by inquiring about the next steps of the development process for 12245 Torbram Road.

Sherry Brioschi provided a delegation regarding a Ministerial Zoning Order issued by the Province to the Rice Group for the property municipally known as 12245 Torbram Road, Ward

3. Ms. Brioschi sought clarification regarding the resolution passed by Council concerning the notification of the public for planning and development projects in the community. She raised concerns regarding the processes and procedures surrounding public information meetings and decision making. She noted additional concerns regarding transparency and accountability, specifically relating to the financials of the project. Ms. Brioschi concluded her delegation by requesting the Town provide a full financial report on the project be made available to the public.

Kathleen Wilson provided a delegation regarding a Ministerial Zoning Order issued by the Province to the Rice Group for the property municipally known as 12245 Torbram Road, Ward 3. Ms. Wilson expressed concerns about the way in which the MZO was obtained, the process of notification and the ability to provide input. She raised additional concerns regarding the development's potential effects on environmentally sensitive and prime farmland and the impact of the building plan on the community, specifically relating to parking, noise and light pollution, dirt and debris in the community, and home valuation.

Irene Ford provided a delegation regarding a Ministerial Zoning Order issued by the Province to the Rice Group for the property municipally known as 12245 Torbram Road, Ward 3. Ms. Ford raised concerns regarding zoning requirements, green belt protection and the addition of previously protected lands. She noted additional concerns regarding the potential effect on endangered species and requirements outlined in the Source Protection Information Plans and Town By-laws. Ms. Ford expressed concerns regarding the proposed warehouses, size of the warehouses and potential increase in truck travel in the community because of the development.

Cheryl Connors provided a delegation regarding a Ministerial Zoning Order issued by the Province to the Rice Group for the property municipally known as 12245 Torbram Road, Ward 3. Ms. Connors echoed the concerns raised by the previous speakers regarding the MZO and how the Town handles such requests.
