#### **REGULAR BUSINESS**

1. Summer / Fall Event Planning and Scheduling

Directors discussed hosting Fall Markets beginning in September and ending in October. It was discussed that markets may take place on Saturday mornings in the Downtown Bolton Royal Courtyards. Directors discussed sponsorship opportunities, marketing initiatives, signage, the number and fees for vendors and the cost associated with leading the event.

Ms. Medeiros noted benefits for hosting the Fall Market and commented on the cost per vendor.

Councillor T. Rosa presented the outline of an Oktoberfest event. He discussed the event structure, being similar to the recent Cinco De Mayo event, including location, vendor information, sponsorships and stage performances. Directors discussed the opportunity and asked questions about the event. Councillor T. Rosa was requested to bring additional information to the next Bolton Business Improvement Area meeting.

With consensus of the Directors, these matters were referred to the Events Subcommittee for further research.

Directors discussed opportunities to further promote the Bolton BIA including sponsored bike racks, Downtown Bolton activations and banners.
