Whereas accessing Town Committee and Council agendas requires access to a computer or the capability to download documents; and

Whereas community members may be incapable of obtaining agenda materials, bylaws, minutes on the town's website; and

Whereas enhancing public access to town information is within the Governance Review Committee's main role; and

Whereas the provision of printed agenda cover pages will allow for ease of access to relevant information for the public attending meetings in-person with greater understanding and engagement in local governance; and

Whereas community engagement and feedback on Town governance matters is within the Governance Review Committee's main role and feedback on obtaining access to printed agendas at meetings has been prior feedback received from the community; and

Whereas only printing as required, including only the cover pages limits the use of resources and wastage; and

Whereas the Clerk confirmed Town of Caledon committed to a paperless agenda management system in the 2015 budget and no Council decision was located to explicitly commit to going paperless; and

Whereas the Clerk confirmed there are no Council decisions from this Term of Council which would require reconsideration to provide printed copies of agendas;
