Whereas the Town is desirous of enhancing the economic viability of the Highway 50 corridor and surrounding area in Bolton; and

Whereas Bolton is the eastern gateway into the Town of Caledon; and

Whereas the Town of Caledon has long advocated for the establishment of a GO Station in the Town of Caledon; and

Whereas the Town of Caledon recently approved the rezoning of lands adjacent to the existing railway line in Bolton that will see the addition of 3,500 new residential units; and

Whereas an increase in residential population is expected along the Highway 50 corridor years in advance of any similar increase in the current "major transit station area" located within the lands commonly known as "option 3" due to the presence of water and wastewater infrastructure which does not currently exist in "option 3"; and

Whereas increased transit options for Caledon residents assists in establishing complete and walkable communities; and

Whereas increased transit options will also assist area businesses in their ability to attract and retain staff; and

Whereas a GO Station along Highway 50 will assist the Town is meeting its pledge of attracting 125,000 jobs given its proximity to Caledon's largest business cluster; and

Whereas the Town's desire to see reduced greenhouse gas emissions is aided by increasing transit options; and

Whereas the addition of a GO Station along Highway 50 would serve as a catalyst for further transit integration across Caledon providing more access options for residents; and

Whereas any GO service traversing the Town of Caledon would first have to pass through the Highway 50 corridor;

Therefore be it resolved that staff be directed through the CAO to prioritize engaging the province in a dialogue regarding the establishment of a GO Station at Highway 50 in Bolton; and
