7.1 Shanon Sommerville regarding agenda item 12.2 Councillor D. Maskell - Request to Oppose the Construction of Highway 413

Shanon Somerville delegated on agenda item 12.2 Councillor D. Maskell - Request to Oppose the Construction of Highway 413. Shanon expressed concerns regarding the construction of Highway 413 and discussed the alternative means transportation can be

addressed, such as increased public transit and use of tolls on Highway 407. She requested Council advocate against Highway 413.

7.2 Betty de Groot regarding agenda item 12.2 Councillor D. Maskell - Request to Oppose the Construction of Highway 413

Betty de Groot delegated on agenda item 12.2 Councillor D. Maskell - Request to Oppose the Construction of Highway 413. Betty expressed concerns regarding Highway 413 and noted the continuous efforts of the community to advocate against the construction. She commented that the proposal does not consult indigenous groups, would have negative impacts on the environment, the concerns of Bill 212 circumventing planning assessments and road safety due to increased truck activity. She commented on the actions of neighboring municipalities and requested Council align with their stance.

7.3 Angela Piscitelli regarding agenda item 12.2 Councillor D. Maskell - Request to Oppose the Construction of Highway 413

Angela Piscitelli delegated on agenda item 12.2 Councillor D. Maskell - Request to Oppose the Construction of Highway 413. Angela commented on the negative environmental impact and the strain the proposal puts on homeowners, especially the senior age group. She requested Council advocate against Highway 413.

Kathleen commented on the demand for aggregate in this community that would be difficult to sustain and the increase of truck-related activity if this highway were to come forward. Kathleen noted that there is no environmental assessment or review. Kathleen commented on the history of Highway 413 in Caledon and requested Council advocate to oppose Bill 212.

7.6 Sherry Brioschi regarding agenda item 12.2 Councillor D. Maskell - Request to Oppose the Construction of Highway 413

Sherry Brioschi delegated on agenda item 12.2 Councillor D. Maskell - Request to Oppose the Construction of Highway 413. Sherry commented on the rapid growth Caledon is experiencing and discussed the measures discussed in Bill 212 that would expropriate property. She supported the motion to Request to Oppose the Construction of Highway 413.

Ian commented on Bill 212 and the arbitrary process for expropriated lands without environmental impact assessments. He commented on the compliance of Bill 212 with future provincial plans which would limit the public's ability to provide meaningful comment. He commented on his support of the motion and requested further advocacy from Council.

Whereas, in October 2023, during the scheduled Peel Region Public Information Centre (PIC), presented by the Ontario Ministry of Transportation (MTO), it was acknowledged that Highway 413 will: traverse four (4) distinct watersheds (Credit, Humber, 16 Mile and Etobicoke), impact 42 dominant or seasonal fish habitats (spawning areas), increase both annual vehicle kilometer traffic and CO2 emissions and disturb at least 44 culturally significant heritage sites; and

Whereas the charity Environmental Defence obtained documents through a recent Access to Information and Privacy (ATIP) request that indicate that Highway 413 will threaten the critical habitats of at least ten (10) Federally protected species at risk that are either Threatened or Endangered and a further ten (10) that are species at risk with the status of Special Concern; and

Whereas, in October 2024, the Government of Ontario tabled Bill 212, Reducing Gridlock, Saving You Time Act, which included the Building Highways Faster Act and the Highway 413 Act; and

Whereas, the Building Highways Faster Act, in Section 3.1 would prevent a Caledon property owner from applying for an adjustment to the date of possession specified in a notice of possession, overriding the protection provided in subsection 39.3 of the Expropriations Act. Subsection 39.3 allows a registered property owner the right to

apply to a judge for an adjustment to the date of expropriation specified in Section 39.2 as three months; and

Whereas, the Building Highways Faster Act, in Section 12.4, on a first offence, imposes, on a Caledon resident who interferes with an expropriation, a fine of not more than \$50,000, plus not more than an additional \$10,000 for each day on which the offence continues; and

Whereas, the Building Highways Faster Act, in Section 13.6, authorizes entry into the private dwelling of a Caledon resident; and

Whereas, the Building Highways Faster Act, in Section 13.9 authorizes the use of force to take possession of land owned by a Caledon resident; and

Whereas, the Highway 413 Act, in Section 2.1 provides for the following exemptions from the Environmental Assessment Act:

- 1. The Highway 413 Project including any change to the 413 Project
- 2. The Highway 413 early works project

... 6. Any prescribed enterprise or activity or proposal, plan or program in respect of an enterprise or activity that is for or related to Highway 413 or extensions of Highway 410 and Highway 427 to connect them with Highway 413; and

Whereas, the Highway 413 Act, Section 3.2 allows the Minister to make changes that do not accord with the final environmental impact assessment as outlined in Sections 8.4 and 9.8; and

Whereas, the Highway 413 Act, in Section 6.4 allows the Minister to, in his opinion, to prohibit the publication of studies or updates of studies that contain sensitive natural or cultural heritage matters; and

Whereas more than 45% of the proposed 52km highway 413 will be built across Caledon;

Kate Hepworth discussed statistics from the 2024 Ministry of Transportation Draft Study and the speeding data pertaining to Caledon. Kate supported the implementation of more ASE cameras in Caledon.

12. NOTICE OF MOTION

12.1 Councillor D. Maskell - Truck and Traffic Calming for Pedestrian Protection in Ward 3 Caledon East

Moved by: Councillor D. Maskell Seconded by: Councillor C. Napoli

Whereas the Town of Caledon has proclaimed a Road Safety Emergency; and

Whereas the Region of Peel's Vision Zero traffic safety commitment states that "no loss of life is acceptable due to a motor vehicle collision" and that "safety is prioritized over other factors such as cost, speed, delay, level of service, and convenience;" and

Whereas Peel's Good Movement Long Term Plan (GMLTP) prioritizes safety and community and environmental sustainability, among many things; and

Whereas both Airport Road and Old Church Road, both of which pass through the village of Caledon East, are currently designated as truck routes in Peel's Strategic Goods Movement Network (SGMN); and

Whereas safety of pedestrians within Caledon East is a rising concern due to truck traffic at the intersection of Airport Road and Old Church Road, which commonly sees more than 70 trucks passing through it each hour; and

Whereas pedestrians in the village of Caledon East have historically jaywalked because there is no formalized protected crossing on Airport Road north of Old Church Road to Charleston Side Road; and

Whereas the posted speed limit in the Community Safety Zones on Airport Road and Old Church Road is 50 km/h as compared to the 40 km/h limits in other Community Safety Zones in the villages and towns of Inglewood, Cheltenham, Terra Cotta, Alton, Palgrave, and Bolton; and

Whereas drivers, specifically heavy trucks, are more familiar with a full traffic signal compared with a pedestrian crosswalk when transitioning into a village from a rural road, especially when there is no formal gateway into the village that would naturally slow traffic; and

Whereas a petition asking for a traffic signal at the intersection of Walker Road and Airport Road, north of Old Church Road, has been signed by 300 Caledon residents;

Therefore, be it resolved, that the Town of Caledon calls on the Region of Peel to:

- Reduce the speed limits in the Community Safety Zones on Airport Road and Old Church Road to 40 km/h immediately, consistent with other villages in Caledon, to not only to improve safety but also potentially deter trucks from taking Airport Road in Caledon East; and
- Further, upgrade the planned pedestrian crosswalk at the intersection of Walker Road and Airport Road, to construct a fully signalized, four-way intersection with traffic lights as soon as possible, and
- Further, as the Strategic Goods Movement Network (SGMN) and the Transportation Master Plan (TMP) are revised, consider the removal of Airport Road's designation as a truck route from Charleston Sideroad to Olde Baseline Road, except during required emergency detours due to temporary closures of ON Highway 9, and
- Lastly, as the SGMN and the TMP are revised, consider the removal of Old Church Road's designation as a truck route from Airport Road to Regional Road 50, except during required emergency detours due to temporary closures of ON Highway 9.
