Subject: Recommendation to List Properties of Cultural Heritage Value in

Belfountain, Cheltenham and Caledon East on the Heritage

Register

RECOMMENDATIONS

That the 87 properties identified on Schedule A to Committee Report 2019-0151 be listed on the Town's Heritage Register under section 27 (1.2) of the *Ontario Heritage Act*; and

That the necessary action be taken by staff to give effect thereto.

REPORT HIGHLIGHTS

- The Built Heritage Resource Inventory (BHRI) identified 1643 properties that have heritage significance. Currently, there are approximately 1169 properties still eligible for listing.
- The Town has 135 properties currently listed on the Town's Heritage Register, 128 individual designated properties and 184 designated properties in Bolton's Heritage Conservation District, under the *Ontario Heritage Act*.
- Heritage Planning are recommending a phased approach to bring forward the remaining 1169 properties onto the Register upon confirmation of heritage significance and the most up to date heritage status.
- The next phase is to list 87 properties of cultural heritage value that have been identified within and immediately adjacent to the boundaries of the Villages of Belfountain, Cheltenham and Caledon East that are not currently protected under the *Ontario Heritage Act*, onto the Register. Thereby providing interim protection from demolition to these properties by means of listing on the Town's Heritage Register under section 27(1.2) of the *Ontario Heritage Act*.
- The remaining properties identified on the BHRI will be brought forward in a similar phased approach.

DISCUSSION

In 2005, the Town commenced a municipal-wide Built Heritage Resources Inventory of pre-1946 structures (BHRI), which identified built heritage resources on 1,643 properties. The final report entitled *Town of Caledon Built Heritage Resources Inventory Report of Findings* (commonly referred to as the BHRI) was presented to Council in 2008.



The report identified specific categories of interest of which 361 were considered as High Significance for architectural integrity (approx. 211 remain at risk), four (4) areas. Cheltenham, Alton, Silver Creek and King Street in Bolton were identified as significant enough to be considered Heritage Conservation Districts and nine (9) areas were also identified as areas of Cultural Heritage Character.

Since 2009, the Town has:

- designated its first Heritage Conservation District in Bolton (184 properties)
- designated 32 individual properties
- listed 110 properties
- identified Alton and Cheltenham as potential Heritage Conservation Districts with funding allocated in the budget for 2019 (Alton – capital project #19-143 Heritage Designation Studies). Funding will be requested in 2021 (Belfountain) and 2022 (Cheltenham), subject to council approval.

In 2018, Heritage staff commenced a review of the original 1643 properties identified in the BHRI and determined that only 1169 are still eligible for listing - 392 within settlement areas and 777 in the rural areas. In addition to a review of the inventory, the individual property information sheets have been updated with enhanced photos and mapping.

With increasing pressure on identified BHRI properties through development applications and demolitions, Heritage Staff recommend a phased approach to listing the appropriate properties remaining in the settlements beginning with:

- Belfountain 21 properties
- Cheltenham 18 properties
- Caledon East 48 properties

Of the above noted properties sixteen (16) are noted as having High Significance in the BHRI Report.

Listing these settlement areas with updated and appropriate information will complete some of the background work for the Heritage Conservation District projects previously noted.

By breaking the BHRI down into a phased work plan, will allow staff resources to be allocated in a more efficient manner and preparation can be made in advance for notification to owners as clear dates and deadlines will be established. The following will also be achieved by this approach:

- preference of Heritage Caledon to bring the settlement areas first
- effectively allocating staff resources dealing with inquires, communication roll out and follow up when necessary



- identifying settlement areas first will assist with commencing the Alton and Cheltenham HCD's
- follows the recommendations of the 2009 BHRI report
- updated list of the properties of heritage interest within the Town
- when planning applications come in for alterations to listed buildings, response time are improved (building and planning staff can give information about listing status immediately versus now where staff may need to look up various inventories and response time is longer)
- protection of key heritage resources and avoid unnecessary building loss
- allows the Town to identify and prioritize properties for future individual and district designations

In 2017, Council took a similar approach with Alton by approving the recommendation to list 100 properties, as non-designated properties on the Town's Heritage Register under section 27 (1.2) of the *Ontario Heritage Act* (*the Act*) on the Heritage Registry, prior to approving funding for a Heritage Conservation District Study. The HCD process for Alton will commence later this year.

The Ontario Heritage Act

Under section 27 (1.2) of the current *Ontario Heritage Act*, notice to property owners is **not** a requirement for Listing a property on the Heritage Register. However, the changes to the *Ontario Heritage Act* under Bill 108 require that notification will be given to property owners within 30 days of including their properties on the Heritage Register. In keeping with the new regulations, Heritage Staff will send out notification letters <u>upon the acceptance of this Report</u> and confirmation of the properties listed below in Tables 1-3 by Council. For the listing of heritage properties this process exceeds the requirements of Bill 108.

Both the current *Act* and proposed changes in Bill 108 requires owners of 'listed' properties to give Council at least 60 days' notice in writing of their intent to demolish any structure(s) on that property. This 60-day period provides interim protection from demolition for the built heritage resources on the property and allows Council to determine if it wishes to protect the property through designation or allow demolition of the built heritage resources.

Based on this review, the number of properties in Belfountain, Cheltenham and Caledon East with cultural heritage value that are not currently protected under the *Ontario Heritage Act* is 87. Tables 1-3 below list these 87 properties being recommended for listing by street for which individual summary sheets of these properties are provided in Schedule A.
