PRESENTATION/ DELEGATIONS:

David Arbuckle, General Manager of Strategic Initiatives, including Economic Development, Town of Caledon

Mr Arbuckle stated that an Economic Strategy Report was last done in 2012 and a creation of a new Economic Development for the town is to look at downtown cores. The timing is for November to go to Senior Management and then to council in March of 2020. They are looking to provide all service to cores and that it was time for downtown Bolton to get some TLC. They are looking to dedicate some extra provisions \$ for downtown Bolton and need a vision with a consultant, Heritage District, and the BIA needs to be in the front with the visioning exercise. The consultant will be sending out surveys to businesses and residences.
