CALL TO ORDER

Chair J. Innis called the meeting to order in the Council Chamber at 2:33 p.m.

PRESENTATIONS

1. Stormwater Management for a Changing Climate

Christine Zimmer, Senior Manager, Water and Climate Change Science, Credit Valley Conservation and Fuwing Wong, General Manager, Finance and Infrastructure Services, Town of Caledon provided a presentation regarding Stormwater Management for a Changing Climate. Ms. Zimmer provided an overview of the benefits and risks relating to stormwater management and outlined how adaptive management is critical to a changing climate. She outlined the four key strategies within the Peel Climate Change Partnership, including Low Carbon Communities, which the Town leads on behalf of the partnership, Flood Strategy, Green Natural Infrastructure, and Public Education. Ms. Zimmer concluded her presentation advising that stormwater management requires the right balance between prioritizing high-risk areas and evaluating solutions to reduce risk. Mr. Wong outlined the Town's efforts and progress relating to stormwater management.

Members of Council asked questions and received responses from the presenters.

2. Town Hall Campus Master Plan

Tom Darlow, Manager, Facilities, Town of Caledon provided a presentation regarding the Town Hall Campus Master Plan. Mr. Darlow provided a conceptual overview of projects contained in the Plan, including Town Hall and Caledon East Community Complex expansion, a skate park, parking and community garden. Mr. Darlow advised that an Optimization Study is being conducted by Town Hall to consider efficiencies in space and technology.

Members of Council asked questions and received responses from Mr. Darlow.

3. Works Yard Strategic Plan

Tom Darlow, Manager, Facilities, Town of Caledon provided a presentation regarding the Works Yard Strategic Plan. Mr. Darlow highlighted the recent expansion of Yard 1, proposed expansion of Yard 2 and a new Yard 3 in the south-west area of the Town to occur over the next ten years.

Members of Council asked questions and received responses from Mr. Darlow.
